REGULAR BOARD MEETING MINUTES

CALL TO ORDER/ROLL CALL: Board Chair Mr. Tom Allen called the Regular Board Meeting to order at 0900 hours. Members of the Board that attended the meeting included: Board Chair Mr. Tom Allen, Board Clerk Mrs. Nancy Schuster, Mr. Jeff Jamieson, Mr. Paul Ober, and Mr. Bob Simmons. See the attached sign-in sheets for Santa Rita Fire District staff, Santa Rita Fire Corps, and members of the public present.

PLEDGE OF ALLEGIANCE: Mr. Tom Allen led the members of the Board and staff in the Pledge of Allegiance.

CALL TO THE PUBLIC: There were no members of the public present who wished to address the Board.

REPORTS AND CORRESPONDENCE

A. Consent Agenda- Mr. Bob Simmons made a motion to approve all items on the consent agenda as presented, and Mr. Jeff Jamieson seconded the motion. All were in favor, and the Consent Agenda was approved (5-0).

1. FINANCIAL UPDATE: Mr. Gabe Buldra

May Financial Report- Mr. Gabe Buldra presented the financial report and advised that for the month of May tax-levy revenue was over budget by \$1,055,201 at \$2,548,845 budgeted at \$1,493,644. Non-tax levy revenue was over budget by \$272,591 at \$451,198 budgeted at \$178,607. Personnel expenses for the month were \$954,700 which was under by \$134,786 budgeted at \$1,089,486. Buildings and Fleet

were over this month by \$44,930 at \$139,920 budgeted at \$94,990. This month, Communications came in over budget by \$5,139 at \$31,245 budgeted at \$26, 106. Managerial came under budget by \$13,498 at \$56,468, budgeted at \$69,966. For the YTD expense percentages breakdown: Personnel is the largest at 81%, Communications is at 5%, OPS is at 8% and Managerial is at 6%. The District's cash position is at \$19,070,788 which is up from \$15,001,020 this time last year. The District's total debt is down by approximately \$149,191. There were no questions asked. The complete report is on file. Mr. Bob Simmons made a motion to approve the financials as presented. Mrs. Nancy Schuster seconded the motion. All were in favor, and the financials were approved, (5-0).

B. CHIEF'S REPORT: Chief Wunder -

Employee/Community Recognition -

- 1. Employee/Community Recognition Chief Wunder recognized several individuals for their exceptional service and contributions to the district. Susan Jones was honored for completing 1,500 volunteer hours, and Steve Dreier was recognized for 500 hours; both received volunteer service pins. Bob Budnick was presented with a certificate of recognition from the Governor in acknowledgment of his outstanding volunteer service exceeding 6,000 volunteer hours. Chief Wunder also formally recognized Engineer Zamora on his promotion to the rank of Captain. Additionally, Chief Wunder also took a moment to acknowledge the recent passing of Chaplain Harms, expressing appreciation for his meaningful integration and contributions to the community. Chief Wunder concluded by expressing his sincere gratitude to all staff and volunteers for their continued hard work and dedication to the district.
- **2. Legislative Issues-** Chief Wunder informed the Board that there were no major updates at this time. Chief Wunder noted that the state budget remains the primary legislative focus at this time. The only anticipated update pertains to wildland appropriations.

- **3. GVFFA Meet & Confer Update** Chief Wunder reported that the Meet and Confer group has convened multiple times to review and discuss various policies. Several of these policies were subsequently presented and approved through the Consent Agenda. A strategic planning meeting is scheduled for August to outline priorities and initiatives for the upcoming year.
- **4.Administrative/Management Update**Chief Wunder reported that finalizing the budget has been the primary focus. He also introduced Miss Ynnah Bautista, the District's intern from the JTED program, and recognized her for her hard work and contributions during her time with the team. There was one question asked and Chief Wunder answered that question accordingly.

C. OPERATIONS REPORT: Deputy Chief Van Alstine

- **1. Response Data** Deputy Chief Van Alstine filed a written report with response and transport data for the month of May. There were no questions asked. The complete report is on file.
- **2. Training and Communications** Deputy Chief Van Alstine filed a written report on Training for the month of May. There were no questions asked. The complete report is on file.
- **3. Health and Wellness/ BLS** Deputy Chief Van Alstine filed a written report on the NP Program and BLS classes for the month of May. There were no questions asked. The complete report is on file.
